**GENERAL RANGE SAFETY RULES AND REGULATIONS**

**POLICY STATEMENT**

Clay Range Events (Pty) Ltd utilise the administration and day to services of Clay Pigeon Adventures (Pty) Ltd hereafter "Clay Pigeon" to conduct the day to day administration at the shooting range.

By subscribing to Clay Range Events (Pty) Ltd you also subscribe to the rules and regulations as set down and prescribed by Clay Pigeon.

Clay Pigeon's policy as a dynamic, successful organisation to conduct all its business dealings on a basis of respect for the law and proper regard for ethical business practices.

Clay Pigeon's reputation and success is built on the integrity of our business affairs. We strive to prevent any situation that may compromise these principles on our dealing with clients, suppliers and other business associates.

Clay Pigeon, including its Staff shall always comply with the Firearms Control Act, 2000 (Act no. 60 of 2000), its Regulations, as well as comply with the rules and regulations of the NRCS, SABS as well as SAPS standards, with respect to running and operating a Shooting Range.

**GENERAL SAFETY RULES**

Unsafe handling of firearms or unsafe practices will result in the immediate sanction and if necessary, suspension of any person/s using the range or premises of Clay Pigeon, or a visitor / spectator may be asked to leave the range and Clay Pigeon premises, whether such person be a member or a visitor or guest and/or spectator.

Examples of unsafe practices are as follows, but are not limited to the following:

1. Endangering any person, including yourself.
2. Pointing the muzzle of a firearm beyond muzzle-safe points.
3. Handling a loaded firearm except whilst, in a designated area or under the control of a range officer / instructor.
4. Carrying a loaded firearm on the premises, as all firearms are to be carried in an unloaded condition at all times and may only be loaded on the firing line on the designated shooting ranges.
5. No Firearms may be handled in any area or anywhere on the premises of Clay Pigeon, even if unloaded, except on the firing line or under the control of a range officer / instructor and in a designated shooting bay or safety area.

There are only 3 instances in which a firearm may be used:

1. While engaging targets on the shooting line and under the supervision of the range officer / instructor.
2. On the verbal instruction from the range officer / instructor.
3. Within a designated safe area.

**BASIC RANGE RULES:**

1. Always keep the firearm pointed downrange and in a safe direction and away from other shooters.
2. Always keep your finger off the trigger until you're ready to fire.
3. Always treat your firearm as if it were loaded.
4. Always know your target and what is beyond the target.

Before taking part in shooting, every person at the shooting range must wear both eye and ear protection in order to satisfy the requirements of the Occupational Health and Safety Act.

This equipment must be provided to any person on the shooting range, even if they do not have their own equipment.

Special emphasis is given to inspection of the shooters' equipment as follows:

1. Eye protection: The eye protection must fit properly and provide the shooter with clear vision and if the eye protection is in poor condition, it will obscure the shooter's vision, possibly creating an unsafe situation.
2. Ear protection: on the shooting range, you may either wear ear plugs or muffs, which ear protection must fit properly and be undamaged in any way that would affect the protection they are there to provide.
3. Holster: The holster must hold the firearm securely in place and there should be no damage to the holster that could affect safety.
4. Clothing and wearing apparel must be comfortable and should not obscure the holster or the belt in any way whatsoever.
5. The belt should be able to carry the weight of the holstered firearm comfortably.
6. The firearm must be in good working condition. It should not have rust or any other obstruction or damage and the correct ammunition for the type of firearm shall only be used.
7. In order to avoid safety infringements, the new member must be advised as to how they are expected to behave on the shooting range and the correct protocol must be provided to avoid any embarrassing or unsafe situation occurring with the new member.

### **PROTOCOL:**

- **Adhere to all farm signage and the strict 40km per hour speed restriction.**
  - **APP - Install and Activate while on the property.**
  - **Zero tolerance policy.**
1. When arriving at the shooting range, the firearm must be in a bag, box or holster.
  2. When arriving at the shooting range, do not remove the firearm from the bag, box or holster, except in designated, safe unloading area.
  3. The shooter is to report to a range officer or instructor immediately.
  4. It is the duty of the range officer and/or instructor to explain to the shooter the range rules and as to how they expect all persons to act and interact with one another and all persons are expected to adhere to the said range rules.

### **USE OF THE SHOOTING RANGES**

The shooting range shall only be used with either the range officer or Instructor of Clay Pigeon on Clay Pigeon's permission. All range rules apply when permission has been granted.

Every person using the range shall also acquaint themselves with this document as well as, including demarcated signage on the various ranges as well as at various part of the premises of the company, and any amendments or training procedures and also the conditions of the shoot itself in which the particular person/s has entered, as no case of ignorance shall be entertained.

When on the firing line, the person/s using the ranges must comply with the instructions given by the range officer/instructor.

Any person who acts in any way that may prove dangerous or commits an offence, shall be liable to immediate suspension / removal from the range and the range officer / instructor on duty, shall have the power to deal with such person as he/she deems fit.

No firing shall take place except from the firing line and in the safe direction downrange.

All firearms shall be unloaded before the firing line is cleared.

The Company may in its discretion, make or amend such rules or regulations for the safe conduct of shooting, provided that such rules and regulations do not conflict with the Memorandum of Incorporation of the Company, NRCS standards, SABS, SAPS, SASSETTA, PFTC Rules and Regulations and/ or provisions of the Firearms Control Act (Act 60 of 2000) and its Regulations.
