## LOURENSFORD MTB Indemnity

For purposes of this agreement, the term “cycling” shall include all activities, services, transportation and use of facilities provided for or arranged by the Releases including but not limited to cycling; bike descents; mountain bike tours; training; use of trails and roads; competitions; instructional courses; or any other activity related to the riding of bicycles and any other vehicles (whether propelled by the rider thereof, self-propelled, or otherwise) including but not limited to: orientation and instructional sessions, transportation, accommodation and recreational activities in addition to bicycling, loading, unloading and travel in movement; and all other activities.

By signing this agreement, the participant acknowledges and agrees to the following:-

1. All participants freely and voluntarily acknowledge and accept that cycling involves risks, dangers and hazards and that injuries, including without limitation, cuts, scratches, broken or fractured bones, sprains, full or partial paralysis, death and any and all losses arising directly or indirectly therefrom, are a common occurrence therein, and that they are cycling entirely at their own risk.
2. All participants whether they be members, visitors or guests of members hereby indemnify Clay Range Events (Pty) Ltd, Clay Pigeon Adventures (Pty) Ltd, Lourensford Properties (Pty), Ltd, Lourensford Events (Pty) Ltd, Lourensford Fruit Company (Pty) Ltd, Karstens Boedery (Pty) Ltd and LOURENSFORD MTB (hereafter jointly referred to as the “Service Providers”), their employees, agents, affiliates or assigns and hold them harmless against any claim which may otherwise be brought by participants, participants executors, estate, dependents or assigns, arising out of any injury to user or users property which user may suffer as a result of any act or omission by the said Service Providers, its agents or assigns whether such act or omission is negligent or not and whether such act of omission takes place while cycling or not.
3. All participants agree that they shall never institute or cause to be instituted any action in any court or arbitration system or procedure, against the Service Providers arising from their cycling at Lourensford Estate.
4. All participants agree to abide by the rules and regulations as well as any directives or instructions of the Service Providers or their duly appointed representatives.
5. In entering into this agreement, all participants acknowledge and agree that they are not relying on any oral or written representations or statements made by the Service Providers with respect to safety of cycling, other than what is set forth in this Agreement.

## **RULES**

Members and day-riders, as the case may be, are expected to act in accordance with the below rules, failure to do so will result in the immediate cancellation of the member's membership, the fees for which shall not be refunded, and expulsion of the member / day-rider from the Estate forthwith:-

### **GENERAL:**

1. All riders must wear the appropriate safety gear, including without limitation, a helmet.
2. All riders shall ensure that their emergency contact information is accurate and current.
3. All riders' bikes shall be equipped with a tracker, which shall be kept on their person (along with an emergency information card) at all times.
4. Riders must be in groups of two or more. No more than 100 riders per time slot.
5. All traffic rules are to be strictly adhered to.
6. All riders must ride in single file on all tar roads.
7. All riders shall close any gates that need to be opened.
8. No swimming or picnicking whatsoever.

### **USE OF THE TRAILS:**

1. No rider shall be permitted to ride on the Estate without having proof of membership or day permit, as the case may be.
2. The cycling club operates on a working farm and the following rules apply in this regard:-
  - 2.1. All riders are required to give right of way to any farm vehicles.
  - 2.2. All riders are required to behave respectfully towards farm residents, workers and animals.
  - 2.3. Riders shall not cause damage to any farm infrastructure or facilities, including without being limited to irrigation systems and fencing.
  - 2.4. Riders shall be conscientious about reporting any obvious damage to the infrastructure and facilities listed above.
3. Riders shall be expected to remain respectful of the environment, which means:-
  - 3.1. No littering;
  - 3.2. No smoking;
  - 3.3. No fires;
  - 3.4. No killing, injuring or threatening any snakes, mice, birds, or other wildlife;
  - 3.5. No picking fruit;
  - 3.6. No picking of any fauna and flora, including without limitation, lillies, proteas, and blooms or blossoms of any other varietal on the Estate;
  - 3.7. No riding through orchards, vineyards, farming, domestic or business premises or any sections other than designated routes;
  - 3.8. Riders shall remain on the designated routes at all times – no new trails are to be made, no riding through orchards or between houses;
4. Riders shall be courteous at all times;
5. No abusive language or behaviour whatsoever shall be tolerated.
6. Ad hoc security stops will be conducted to check rider ID and to ensure safety and security for everyone;

### **USE OF THE TRAILS**

The trails shall only be used with the permission of Clay Range Events or its representatives and all rules apply where permission has been granted.

Every person using the cycle tracks/facilities shall also acquaint themselves with this document as well as demarcated signage on the various trails at various parts of the company premises, and any amendments and also the conditions of the relevant trail which the particular person/s intends to ride, as no case of ignorance shall be entertained.

Any person who acts in any way that is contrary to the aforementioned rules or that may prove dangerous or commits an offence, shall be liable to immediate suspension / removal from the Estate and LOURENSFORD MTB/Clay Range Events reserves the right to enforce such disciplinary measures in it's sole discretion as it may be entitled to do in law, or as it deems fit in it's sole discretion.



The Company may in its discretion, make or amend such rules or regulations for the cycling club, provided that such rules and regulations do not conflict with the Memorandum of Incorporation of the Company, or the relevant legislation and regulations applicable as the case may be.
