## GENERAL SAFETY RULES AND REGULATIONS

### POLICY STATEMENT

By subscribing to Clay Trout, you also subscribe to the rules and regulations as set down and prescribed by Clay Trout.

Clay Trout’s policy as a dynamic, successful organisation to conduct all its business dealings on a basis of respect for the law and proper regard for ethical business practices.

Clay Trout’s reputation and success is built on the integrity of our business affairs. We strive to prevent any situation that may compromise these principles on our dealing with clients, suppliers, and other business associates.

### RULES & USE OF THE FISHING VENUES:

Members, monthly fishing guest and non-fishing spouse/partner, are expected to act in accordance with the below rules, failure to do so will result in the immediate cancellation of the member’s membership, the fees for which shall not be refunded, and expulsion of the member from the Estate forthwith: -

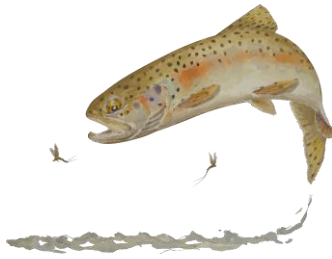
1. All members shall ensure that their emergency contact information is accurate and current.
2. All members shall be equipped with a tracker/Tracking App, while on the farm, which shall be always kept on their person (along with an emergency information card).
3. All traffic rules are to be strictly adhered to. (40km/h)
4. Fly Fishing ONLY
5. Barbless fly-fishing only
6. One Rod per member
7. No spinning, bait, lures or keep nets
8. Catch and release is only permitted if fish is unharmed
9. Member can only book one venue per morning/afternoon session.
10. Only paid-up members may book & Strict adherence to booking session times
11. Members are welcome to bring their spouse/partner to accompany them but not fish, unless booked as a monthly fishing guest.
12. Maximum of 2 people per vehicle
13. Contact Noel Rowe – 076 349 2866 – if you see anyone transgressing the Fly Fishing Rules
14. One free fish a month. ONLY from the Pools. All fish taken to be reported to Clay Hub.
15. No member shall be permitted to fish on the Estate without having proof of membership or day permit.

16. Car Top Hat must be displayed when driving on the Estate:
  - Blue Top Hat – Blue Gum Dam
  - Red Top Hat – River Beats
  - Green Top Hat – Oaktree Pools
17. The fishing club operates on a working farm and the following rules apply in this regard: -
18. All vehicles are required to give right of way to any farm vehicles.
19. All vehicles are required to behave respectfully towards farm residents, workers, and animals.
20. Members shall not cause damage to any farm infrastructure or facilities, including without being limited to irrigation systems and fencing
21. Members shall be conscientious about reporting any obvious damage to the infrastructure and facilities listed above.
22. Members shall be expected to remain respectful of the environment, which means: -
23. No littering.
24. No smoking.
25. No fires.
26. No killing, injuring, or threatening any snakes, mice, birds, or other wildlife.
27. No picking fruits.
28. No Dogs
29. No picking of any fauna and flora, including without limitation, lilies, proteas, and blooms or blossoms of any other varietal on the Estate; and
30. Members shall always remain on the designated fishing area – no switching between venues, no driving through orchards or between houses.
31. Members shall be always courteous.
32. No abusive language or behaviour whatsoever shall be tolerated.

Any person who acts in any way that is contrary to the afore mentioned rules or that may prove dangerous or commits an offence, shall be liable to immediate suspension / removal from the Estate and Clay Trout/Clay Range Events reserves the right to enforce such disciplinary measures as it may be entitled to do in law, as it deems fit.

The Company may in its discretion, make or amend such rules or regulations for the fishing club, provided that such rules and regulations do not conflict with the Memorandum of Incorporation of the Company, or the relevant legislation and regulations applicable.
